Students will collect the money up front and pay it to the Finance Office (checks should be written to Salem Hills High School). Lehi Roller Mills will fill orders approximately 4 weeks from the order placement. Students earn half of the the retail price of the product (Product MUST be sold at suggested retail). Students will sell on their own. This fundraiser is NOT required.
